Additional Notes: For international ISDN Data flagged calls - rates quoted are pence per minute. A single call rate applies at all times of the day and week. A minimum call charge of 30 seconds applies.

Charges in this tariff sheet are stated on a Pence per minute basis and call charges are calculated by the second, unless specifically stated otherwise. Call costs are calculated by rounding the call duration up to the nearest Second (or Minute for calls charged by Minute).

Call start times are accurate to within plus or minus one minute. Call durations are accurate to plus or minus 1.1 seconds.

Peak time periods are Monday - Friday 07:00 - 18:59, 'Off Peak' is all other times. Calls that cross between Day, Evening and Weekend boundaries will be charged at the call start time rate.

Post order ECC's (Excess construction charges) or MACC (moves, adds, changes, & cessation) charges may apply - as per standard Terms and Conditions (applicable to both on-net lines & off-net WLR)

Late Payment Charges/Failed item charge with interest on balances may apply in event of default payments, as per standard Terms and Conditions.

Tariffs, Destinations & charges may be changed and services may be modified, added or withdrawn from time to time.
